# Words from Susan DiStefano, Executive Director

21 years ago Hosanna opened the doors at Faith House and welcomed it's first residents. When conceived, the staffing plan was to have house managers who lived side-by-side with the residents. Together, they would run the household. As time passed, it became more and more difficult to hire people to "live-in" and we suspected that this model for staffing had become antiquated. We have now embarked on a new way to staff our homes. Still offering 24/7 coverage, we have hired individuals to work shifts: a day shift, two evening shifts that include prepar-

ing dinner and attending programs, and one shift that is overnight duty. This plan has proven to be a great solution and most importantly, the residents LOVE it. The unintended consequence has been that the residents feel they are living more independent lives. They are more responsible for their houses and make plans without staff input. As we continue to strive to provide as much independence as possible, this is just one more step to empowering our residents to live happy and full lives.

# Numbers Talk! Carolyn Rice, Development Chair


Why do we fundraise? Because we need to!

We are a number of things:

A non-profit organization. We exist to provide quality services to disabled adults, most of who have limited incomes and few options for affordable living situations. This means we serve people regardless of their ability to fully pay for our services.

We are blessed. Our property is paid for, our bank accounts are healthy, we have a small but growing endowment, we have a small emergency fund for events such as the flood of 2009.

We have a need. Every month. Always. Ongoing. The numbers tell the story.



That's right. We need an additional \$10,500 PER MONTH. Our residents pay a part of their rent, but there is still a gap of over \$750 PER RESIDENT PER MONTH.

We DO receive donations, grants, additional rent from families and we DO raise money through fundraisers. A substantial gap still exists.

This is why we ask for your help. And we ask often and repeatedly. Our residents need a place to call home. We need to be good stewards and pay our bills. We are a very lean organization. Frugality is the norm for us.


