







# WORDS FROM SUSAN DISTEFANO, EXECUTIVE DIRECTOR

I know "community" means different things to different people. I speak of it often. Clearly, at Hosanna, we equate community with family.

During the Pandemic, we are truly learning what that means for us. Residents have been in social isolation for over 8 months. The good news is we are Covid free. Our residents are doing amazingly well with their positive attitudes and few

complaints. I am thankful for that....but it actually goes much deeper.

I am on my 11<sup>th</sup> year as director here, and I am always learning and observing new things. This past week was a perfect example. We had a VERY difficult week. One of our residents had an emotional support dog who was very sick. Jett had become a part of our Hosanna family and the residents were struggling with his end-of-life issues. It was amazing to watch them volunteer to help take care

of the dog, to walk him, to spend personal time with him, and to clean up after him when he was sick.

Honestly, I watched in wonder as they came together to help in any way possible. It was inevitable that after multiple trips to the vet that Jett, our sweet Hosanna dog, was reaching the end of his life. One morning when I came in, Kendall, the dog's owner, with tears in her eyes, told me it was time. She called and made an appointment with the vet for that afternoon. I walked the dog and then took him to "work out" class, and I then told the residents what was going to happen. I wanted them to have some closure and be able to say goodbye, hug him one last time and even get a picture with him.

No doubt, they were upset, but here is the amazing thing I observed. They supported and comforted each other. With no staff involvement, they had conversations amongst themselves, comforting each other and giving words of encouragement. Comments were made such as, "He won't suffer any more" or "I know we all will miss him, but that is the circle of life".

I guess in most families, we take grieving for granted, but watching it play out with the residents, some of whom have difficulty with connections, just warmed my heart and continues to reinforce in me that whatever we are doing, we are doing it well. THAT is not just community. That is also family. I continue to be thankful that I am able to serve because I have learned so much.

### David Wells Crippen May 13, 1936 - September 26, 2020

David Crippen, 84, Hosanna's first executive director and ardent supporter its mission since its beginnings, passed away Saturday, Sept. 26, in Florence, CO.

The Rev. Crippen was introduced to the idea of Hosanna in 1992 by Catherine Brown and Molly Miles, both of whom had dreams of establishing an independent living facility for people who have disabilities. By 1995, when construction on Hosanna's Hope House was completed, the Rev. Crippen said, "We have no idea if this is going to work - it's an act of faith." And apparently that was how he lived much of his life.

Mr. Crippen's faith showed strongly in his life, said Molly Miles. "He was a remarkable man, and he really trusted God. One big thing I learned from him was that when you trust in God that things happen in the right time and right place."

Along with siblings, his children and grandchildren and many beloved dogs, he is survived by his wife, Karen, who worked alongside Mr. Crippen as Hosanna's first administrative assistant.
