# WORDS FROM SUSAN DISTEFANO, EXECUTIVE DIRECTOR

We locked our doors in March 2020 and got serious about educating the residents and ourselves about what a pandemic was and what we could do to protect ourselves. We watched videos on hand washing. We put 'DO NOT ENTER' signs on all the doors. We kept hand sanitizer at each door. And we had residents give up work (unless they could work at home) and volunteer jobs. We realized early on, if all the residents were going to be at home all day, it would be necessary to change the way we did things at Hosanna.

Our plan was to keep the residents so busy with exercise classes, crafts, cooking classes and ANY other activity we could think of so that no one would be thinking too hard about Covid. Thank you to all staff members for using their creativity, changing their job roles and keeping residents occupied during this difficult time. Special thank you to Beth and Mary who planned and executed all our daily activities. It has been different, but also has been fun. Most residents are actually in better shape from daily exercise, and they really enjoyed all the activities. Even though we were all locked down together, the residents had amazing attitudes, and we all worked together to get along and support each other. We NEVER thought we would be going through the holidays here at Hosanna with all the residents here, but it gave us a unique opportunity to make this time together special.

Well, it is a year, almost exactly, that we have been able to open our doors. I am proud to say that as a result of Hosanna teamwork, we did not have ANY Covid cases here at Hosanna (including staff). Everyone has now had their vaccine shots, and we our semi-resuming some of our outside activities (with caution).

In retrospect, I know we are fortunate that the worst of it only lasted a year.

Although difficult, it has had its silver lining. We know each other better. I believe we are more compassionate, and we all truly thankful knowing how fortunate we have been to get through a pandemic!

Also special thanks to so many individuals, especially friends and family members, who provided the supplies we needed when we couldn't shop. There were donations of essential items such as paper towels, food, disinfectant, craft supplies, meals carried in from restaurants, and even Christmas gifts! They all allowed us to stay safe.
